City of Seminole Disaster Recovery Program:

Following the devastating tornadoes of May 2022, the City of Seminole worked diligently alongside national, state, and local agencies to ensure residents affected by the disaster could access resources for their immediate needs. A partnership with the Seminole Community Foundation (SCF) was also established at this time to ensure additional funding for long-term recovery needs.

SCF received donations from generous donors from within and outside of our community to support disaster recovery work. Thanks to this funding, the City of Seminole is proud to offer the Disaster Recovery Program. The Disaster Recovery Program will support Seminole, OK residents who have been directly affected by the May 2022 tornadoes.

Program Eligibility Requirements:

The program will provide assistance for necessary repairs directly related to storm damage from the May 2022 tornadoes. In the event a home is considered structurally unsound by the City of Seminole's Code Inspector, relocation assistance — such as assistance with a security deposit or moving costs — may be available. Other requirements are:

- Program recipients must be unable to complete repairs due to financial or personal circumstances.
- Currently a resident of Seminole, Oklahoma.
- Request for assistance must be directly caused by the May 2022 tornadoes.
- Annual household income is below 300% of the federal poverty level.
- Must demonstrate the need for assistance.
- Must have filed an insurance claim.

Due to the nature of the program, applicants applying for personal loss such as property damage must be the property owner. We are unable to work directly with tenants.

Applications for assistance will be accepted until funding is exhausted.
